Board of Directors Meeting Minutes

April 3, 2026, at 9:00 AM in Sophie's Kitchen



- Ron advised he is waiting for a response regarding new signage, however he will work with Roy to hang the old signage in the meantime.
- Marta discussed the lack of and need for volunteer participation from club members. Marta suggested a two-year calendar, with the known upcoming social events, and requesting assistance for those events, which may prompt a better response from the membership. She also discussed the need for creativity when deciding on different types of social events and how to market those events.
- Ron explained that he had prepared a Google calendar to list scheduled events and the ability to link the calendar to the Live Pickleball website. Ron suggested possibly having index cards available during coordinated play (i.e., Round Robin) so that members can use the cards to make social event suggestions.
- The Membership and Social Committee's have been eliminated from the organization chart. Ron and Marta will be point for those two areas.
- Vaughn said he was going to look elsewhere (Surprise) for his men's events. This prompted a discussion between Ron and Tom about "private events" and reserving courts. Further discussion is needed and procedural guidelines established before any motions can be made. Roy made a suggestion about using some whiteboard space for ad-hoc reservations.
- Allen is working on a Liability Waiver Review.
- Ron advised that some changes have been made to the current public website with more changes coming in the next few weeks.

New Business:

- Director Reports (Each Director)
 - Marta discuss her issues in Old Business, nothing further to present.
 - Bob explained that Heidie will be working with Marta to coordinate Event and Marketing materials.
 - Roy explained that he completed mounting locked white board, relocated old board under the kiosk and that Ron has added a erasable monthly calendar to the kiosk. Ron also gave Roy the second key to the locked white board.
 - Tom questioned relevance of the 501(c)(3) , further discussions will need to happen.
 - Discussed revision to the nepotism clause to say "Voting Board Members" , board to review change.
 - The need to develop a communication plan.
- Demo Day event discussed as to food and beverages, Marta to follow up with Social management for details and costs. Look to have a flyer made to publicize the event and tag lines for the web components.
- Pickleball Poker, all set for Friday. May need to pull some cash (\$5 bills) for change.
- ALL Champions Banner & Party
 - Unanimous decision not to pay for any party.
 - Club will cover the cost of the Banner.
 - Ron will work with Christine on design and build.
 - Insure that WR and WRPBC logos are include.
 - Will post on fencing once poster completed.
- A review and approval of the updated Rules and Procedures document was tabled until next meeting, with a possible mid-month review and text approval by the board. Details to be worked out.
